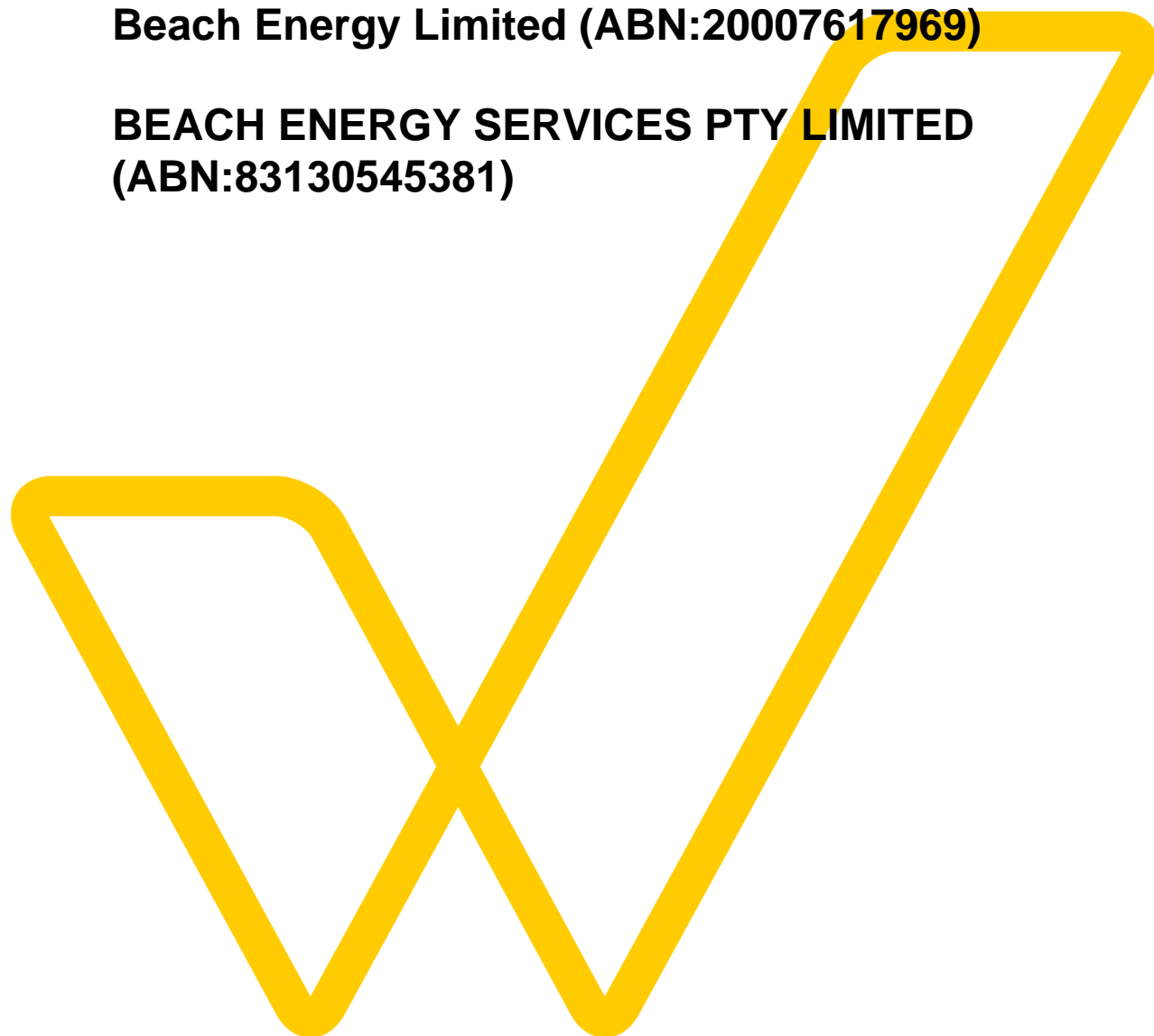

The roll out included employee and leader presentations, updated intranet site of information on the process, how to have the conversation and how to request / record the request via an automated decision workflow. Beach also embarked on Unconscious Bias training (e-module) in support.
